# Minutes of the Annual General Meeting of the Parish Council held on Tuesday 16 May 2023 at 7.30pm at Ightham Village Hall

- **3. REPORTS FROM COUNTY COUNCILLOR AND BOROUGH COUNCILLOR –** Clir Rayner reported closure and reduction of hours in some Household Waste and Recycling Centres (HWRC) in Kent but did not anticipate that this would apply to HWRC's in West Kent. Clir Rayner reported that in the recent Borough Election, there was no overall majority, with Conservatives holding 20 out of 44 seats. Clir Rayner left the meeting at 7.45pm

**6. MINUTES -** The Minutes of the Meeting held on Tuesday 18 April 2023 were approved with a couple of small amendments. The Clerk will amend the minutes and pass to Cllr Willingham to sign.

#### 7. MATTERS ARISING

Highways & PROW Matters - HIP update- Gateways – The Clerk reported that the gateways have been ordered and will be installed within 90 days. Following an inspection by Highways Engineers, the Gateway on Ismays Road will be placed on the verge on A227 rather than on the triangle. It was agreed that we should still pursue 20mph on Oldbury Lane and Spring Lane, despite average speed data being compliant, due to it being a popular pedestrian access route to the nursery and school and lack of pavement. Temporary Road Closure - Rectory Lane, Ightham - 6th June 2023. Temporary Road Closure - A25 Ightham Bypass, Borough Green Road and Sevenoaks Road, Borough Green - 5th June 2023 for 9 nights between 9pm and 5am (access available for residents). Ismays Road closure, Ightham - 15th May 2023. Potholes to report: Redwell Lane, Mill Lane, Sevenoaks Road. Salt bin on Back Lane is empty. Ongoing sewerage smell outside Collingwood – this has been reported to Environment Services. Dirty Signs - Common Road. Poor sight lines A25 entrance to and from the recreation ground. Blocked drains outside Wellwood on Common Road, junction of Coach Road with Sandy Lane and Oldbury Lane /A25. Footpath sign MR418 still missing.

**Allotments** –Update. The Clerk reported that there had been an enquiry about purchasing allotment land but had informed the applicant that it was not available for sale and had not been put forward in the call for sites in the recent Local Plan.

Recreation Ground & Car Park –Wicksteed repairs - we are awaiting a date for the repairs to be carried out. The Clerk reported that we have just been notified about the Rospa Inspection and should wait until we receive the report before chasing up repairs to the wetpour. Container repair – to be done. Installation of memorial bench – Cllr Willingham has asked James Hayward to install the bench. Cllr Fielder asked whether a self-close mechanism could be put on the entrance gate to the recreation ground as it is often left open. The Clerk will ask Wicksteed whether they have any recommendations for safety weights/springs. Graffiti - The Clerk reported that there was a lot of graffiti on the pirate ship, some of it offensive. The Clerk will do a site visit with Cllr Mitchem to see what options were for removing or painting over it. The Clerk will also report this to the Head at Ightham Primary School. PSA Bonfire November - Concern was raised about having a bonfire on the recreation ground due to health and safety concerns and proximity to the trees. Cllr Willingham said that he would speak to the Chair of Governors about the possibility of having it on the school grounds as it would be easier to cordon it off.

**Tennis Club** - Vandalised Path Lights – the path lights have now been repaired and replaced. We have received a quote for some 2 extra CCTV cameras on the scout hut for £1,185. The Clerk reported that the existing cameras had a good view of the grounds. As far as we are aware, there has been no police action following passing over of CCTV footage of the damage being caused to the lights.

**Village Hall** - Update - **Solar Panels** – Cllr Willingham reported that we have been accepted on the Solar Together scheme and are waiting for someone to give us a price. **Changing station** – awaiting installation. **New salt bin** - Clerk to order.

**Flooding** – Busty & drainage mapping – Cllr Holden reported that there had been no issues with the Busty during recent heavy rainfall, Cllr Clark reported that she had removed some wood from the bridge. Cllr Holden reported that he had downloaded the QGIS mapping system and was able to print off maps for the various areas in the village. Cllr Holden said that he would print of maps to hand over to Councillors by the end of May for them to mark up with gulley's/watercourses by the end of July. **Ightham Mote** – Site visit 1st June 2023 at 5pm confirmed. Cllr Willingham reported that National Trust has taken over Oldbury Campsite.

**A25/Spring Lane** – **Bench repair /removal** – Cllr Willingham will ask James Hayward to remove the bench. Cllr Willingham reported that he had found a maintenance man who could paint and treat all existing benches.

**Newsletter** – Printing – request for funding. After some discussion, it was agreed that we would donate £1,500 towards the Parish Magazine and ask for some acknowledgement in the magazine. **Trees** – sites for Queens Green Canopy Trees – suggestion of a screen along the boundary of the Cricket Club with A227 and a Coronation Oak in the recreation ground - to go onto next month's agenda.

**Social Media –** The Clerk reported that she would attend a training KALC seminar on social media and would report back.

TM/23/00865/TPOC - 49 Nutfields, Ightham, Sevenoaks, Kent, TN15 9EA. T1 Ash - front of house - crown reduction by up to 1m leaving residual height of 4m and spread of 3m. T2 Cherry adj to Beech hedge - crown reduction by up to 2m leaving residual height and spread of 4m - thin remaining canopy. T4 Goat Willow in neighbouring property 50 Nutfields, remove 2x low branches over hanging drive. T7 Goat Willow in rear right corner of garden - crown lift to provide 3m ground clearance, reduce remaining crown by 3m from height and up to 2m of spread leaving residual height of 7m and spread of 5m. G8 3x Cherry trees in rear garden - crown lift to provide 3m ground clearance on all 3 trees. Reduce all crowns by 3m in height and 2m spread, leaving a residual height of 7m and residual spread of 4m. All maintenance work for trees standing within Area W1 of Tree Preservation Order. TM/23/00886/FL – Netherwood, Coach Road, Ivy Hatch, Sevenoaks, Kent TN15 0PF. Single storey rear extension, addition of dormer to front elevation, internal alterations, changes to fenestration and materiality. Addition of single storey double bay garage. "We leave to TMBC and question whether this may be overdevelopment".

**TM/23/00928/TNCA** - Ightham Mote, Mote Road, Ivy Hatch, Sevenoaks, Kent, TN15 0NT. G1 (applicants' reference) Group of large overgrown laurel on east side of gate to south lake, between bridle way and builder's yard. Low down screening becoming ineffective. - Reduce to approx 1.5-2m to allow easy maintenance and encourage leaf growth low down to improve screening. Sever ivy on large Hollies by Builders yard access gates. T2 (applicants' reference) - Large, leaning Norway maple, leaning over southwest Garden. - Remove section of chestnut Piling fence to gain access from bridle way. Dismantle tree in sections to near ground level. "No objection."
